Terms and Conditions

Rohese Cattery Terms and Conditions of Boarding

1. A current Vaccination certificate to cover Feline Enteritis and Influenza must be produced for each cat.
2. No cat suffering from or suspected to be suffering from any infections or contagious disease will be accepted. The proprietor reserves the right to refuse admission to any cat showing signs of ill health.
3. In the event of illness or suspected illness we reserve the right to consult our Veterinary Surgeon and any treatment considered advisable will be undertaken at the owners expense.
4. A full day's board is charged for the days of arrival and departure. In the event of owners returning before the end of the period for which the cat is booked the full period will be charged.
5. If for any reason any boarded cats fail to be collected within fourteen days of the specified departure date and no agreement is reached between the cats' owners and the proprietor of Rohese Cattery, we reserve the right to make alternative arrangements.
6. Whilst every care and precaution is taken during boarding, responsibility can only be accepted at the owners' risk.
7. All cats must be neutered or spayed.
8. If it becomes necessary to provide flea or worm treatment during your cats stay, the cost of this will be added to your invoice. It is the owners responsibility to inform us of any allergies your cat may have to flea/worm products.
9. Images of your cat/s may be displayed on our Facebook page. These will be anonymous and not linked with the owner. Please advise if you do not wish images of your cat to be taken.
10. Booking alterations will only be accepted, subject to availability.
11. All boarding and other charges must be paid in full in advance.

These conditions of acceptance will be valid on this and any future stay at Rohese Cattery

Please sign to state that you agree to the terms and conditions and understand that whilst every care and attention is given to your cat/s, they are boarded at your own risk and that we have your permission to call the vet should the need arise and take any action deemed necessary for your cats well being. We also advise that you have your own pet insurance to cover your cat/s for any pre existing condition/s to their stay.
